
While reviewing the progress report of Jammu Province under MGNREGA ending December, 2010, it has been observed that most of the Districts have failed even to spent 50% of the approved Labour Budget for the year 2010-11 when only 2 ½ months of the current financial year have been left. The higher authorities have taken a serious view of the poor performance and I have been directed to further direct you to accelerate the pace of the progress in the remaining months of the current financial year under MGNREGA, so that labour budget is utilized in full. The details of the progress achieved ending December, 2010 of Jammu Province, District-wise is as under:-
