CIRCULAR

It has been observed that certain departments, where the Engineering wing is not headed by an officer of the rank of Chief Engineer or equivalent, do not route the DPRs through concerned Chief Engineer R&B department for necessary check and technical feasibility of the proposed project before same is forwarded to this office for the purpose of accord of technical vetting.

This practice, which is uncalled for, leaves a scope for deficiency or technical flaws in the DPRs which may remain undetected.

All the Head of the departments may therefore impress upon the concerned officers, who are technically heading the engineering wing of the department, that every DPR is routed through the concerned Chief Engineer of R&B department for his technical scrutiny, verification and feasibility failing which the DPR shall not be entertained for technical vetting in this office.

Furthermore the DPRs should necessarily bear the signatures of project authority with approval of drawings and authentication of General Abstract of
