Sanction is hereby accorded to the release of funds to the tune of Rs.39.68 lacs (Rupees Thirty Nine lakhs and Sixty Eight thousands) only under CD & Panchayat Sector in favour of Assistant Commissioners Development Jammu ,Ramban, Reasi & Doda for its further placement at the disposal of Block Development Officer concerned for utilization during the current financial year (2010-2011). The constituency-wise/district wise details of works are enclosed as per the annexure "A".

The releases of funds are subject to the following conditions:-

1. That the funds so released shall be utilized for the purpose for which these are released.
2. That all codal formalities shall be observed while incurring of expenditure to observe financial discipline.
3. That there shall not be any duplicacy in adoption of works/incurring of expenditure.
4. The works so identified are subject to the verification of the estimated costs feasibility, permissibility, genuineness to avoid any duplicity & also to avoid any future liability on this account, in addition to other codal formalities
5. The implementing agencies shall ensure that the works are executed only in Rural areas and also keeping in view the spirit of Govt. Order No.117-RD of 2008 dated; 03-04-2008.
6. That the monthly progress reports both physical and financial shall be submitted on regular basis to Directorate of Rural Development Jammu for monitoring of expenditure.
7. The works should strictly be executed as per the instructions conveyed vide Govt. Order No.55-RD of 2010 dated; 27-01-2010.
8. That the work is taken up only after the preparation of proper estimates, Accord of Administrative Approval & Technical Sanction by the competent authority.
9. That the work is executed if it is not a right full charge to any other scheme/schemes.
10. That the expenditure is incurred only after execution of the works and not for clearing past liabilities for the work/works executed if any and also ensure that no other agency has executed the work or included it in any other scheme/programme/project.
11. That the expenditure is restricted to the sanctioned allocation and no liability be created whatsoever.
12. That a committee of local members be constituted by the Block Development Officer for ensuring supervision and quality control of the work.
13. That the Assistant Commissioner Development concerned shall furnish the Utilization



- Certificate of the funds utilized for the works alongwith photographs (both pre and post execution of works executed).
14. That the drawing and disbursing officer before making the payment shall ensure the funds are utilized prudently and judiciously and in no case should book the expenditure just for the sake of expenditure
  15. That the funds released against the works falling in constituencies which are part of two Districts shall be utilized as per jurisdiction of the District by the concerned.
  16. The expenditure shall be debited to the appropriate account head of CD & Panchayat.



