The appointee shall be allowed to join only on the production and verification of the following certificates in original:-


1. Permanent Resident Certificate.
2. Qualification Certificate
3. Date of Birth Certificate
4. Health Certificate
5. Certificate from Deputy Director, Employment and General Manager, DIC concerned relating to the non-receipt of any loan by the candidate under Self Employment scheme and Prime Minister Rozgar Yojana.
6. Category certificate, if any required.

The appointment shall be subject to the following conditions:-

- a). The appointee shall give an undertaking in the shape of an affidavit to the effect that in case any adverse report about his character and antecedents is received from the Addl. Director General of Police, CID, J & K, to whom a reference shall be made by the Assistant Commissioner Development, Reasi, the candidate shall have no right to claim his appointment as Village Level Worker and as such shall be deemed to have been cancelled *ab-initio*.
- b). Verification of the qualification certificate from the concerned issuing authorities.

- c). Salary of the appointee shall not be drawn and disbursed to him unless satisfactory report is received from CID J&K.
- d). the appointee shall be on probation for a period of two years.

The inter-se-seniority of the Village Level Workers will be prepared by the Assistant Commissioner Development, Reasi reckoning the merit of each candidate as envisaged in the select list received from the Service Selection Board J & K vide their letter referred to above.
