Sanction is hereby accorded to the appointment of Shri Rajesh Thakur S/o late Shri Chuni Lal (Ex-VLW) R/o Chachwa District Ramban as **Village Level Worker** in the pay scale of Rs.5200-20200 with Grade Pay of Rs.1900/- against an available vacancy in Udhampur District on compassionate grounds in terms of SRO:43 dated 22-02-1994.

The appointee shall report to the Assistant Commissioner (Dev.) Udhampur within a period of 21 days failing which his appointment shall be deemed to have been cancelled without any further notice after the expiry of the stipulated period.

The appointee shall be allowed to join only on the production of the following certificates in original:-

1. Qualification Certificate.
2. Date of birth Certificate.
3. State Subject Certificate.
4. Health Certificate.
5. Death Certificate.
6. Dependent Certificate.
7. Certificate from the General Manager, D.I.C. concerned and Dy. Director Employment concerned to the effect that no loan under Self Employment Schemes has been taken.
8. Any other certificate required under rules.

The appointment shall be subject to the following conditions:-

- a) The appointee shall give an undertaking in the shape of an affidavit to the effect that in case adverse report about his character and antecedents is received from the Additional Director General of Police, Criminal Investigation Department, J&K, to whom a reference shall be made by the Assistant Commissioner (Dev.) Udhampur, the candidate shall have no right to claim his appointment as Village Level Worker and as such shall be deemed to have been cancelled *ab-initio*.
- b) Verification of the qualification certificates from the concerned issuing authorities.
- c) Salary of the appointee shall not be drawn and disbursed to him unless satisfactory report of his character and antecedents is received from the Criminal Investigation Department.
- d) The appointee shall be on probation for a period of two years.
