

Whereas, in terms of J&K Rural Development (Subordinate) Service Recruitment Rules, 2007 issued vide SRO-178 dated: 09-05-2007, a combined final seniority list of Panchayat Inspectors Grade-II and Mukhya Sevikas of Rural Development Department Jammu Division as it stood on 01-10-2016 was issued vide Order No. 504-DRD of 2017 dated: 29-06-2017; and

Whereas, thereafter four (04) Departmental Promotion Committee meetings at the Divisional level in respect of the Village Level Workers/Gram Sevikas against the posts of Panchayat Inspector Grade-II/Mukhya Sevika were held on 08-03-2019, 13-09-2019, 20-02-2020 and 20-06-2020 wherein a good number of officials were promoted from different dates against the substantive available vacancies; and

Whereas, some VLWs who stands cleared for their promotion as Panchayat Inspector Grade-II by the DPC but their promotion orders could not be issued for want of Vigilance Clearance. Now, the General Administration Department (Vigilance) vide their O.M. No. GAD(Vig)12-NOC/2020-RDD dated: 06-12-2019 and O.M. No. GAD(Vig)12-NOC/2020-RDD dated: 17-06-2020 received from the Administrative Department vide communication No. RD&PR/Estt/NG/13/2018 dated: 24-12-2019 and 24-06-2020 respectively whereunder it has been reported that the following VLWs/ I/c BDOs are involved in Regular Departmental Action (RDA) under verification No. as shown against each hereunder:-


Whereas, the aforesaid officials stands already cleared by the DPC for their promotion as Panchayat Inspector Grade-II and it has been found that these six (06) officials shall also be shown in the combined tentative seniority list of Panchayat Inspectors Grade-II at their appropriate place alongwith the conditions shown in the remarks column which was conveyed by the GAD; and

Whereas, at present about Sixty five (65) posts of Panchayat Inspector Grade-I are available. For filling up of these posts in terms of existing J&K Rural Development (Subordinate) Recuritment Rules 2007, from amongst the Panchayat Inspector Grade-II and Mukhya Sevika. However, for considering the same, seniority list of the said category is required to be issued/finalized.

Whereas, keeping in view of the above, it has been decided to issue a combined tentative seniority list of Panchayat Inspector Grade-II and Mukhya Sevika as it stood on 01-07-2020 for inviting objections of the concerned members of the services.

Now, therefore, a combined Tentative Seniority list of Panchayat Inspector Grade-II and Mukhya Sevikas of Rural development Department Jammu as it stood on 01-07-2020 forming **Annexure** to this order is hereby circulated/issued for inviting objections of the concerned members of the services with regard to the position already assigned to them in the said tentative seniority list, if any, within a period of 15 days positively alongwith relevant documentary evidence/certificate from the date of issuance of this order. However, no objections shall be entertained after expiry of the stipulated period of time. The said combined tentative seniority list shall be issued subject to the following conditions:-

1. That the seniority list is without prejudice to the outcome of any Writ Petition(s) pending in the Court of Law.




2. That the entries of date of birth and date of 1st appointment made in the said Tentative Seniority list are subject to the verification from the original service record.
3. That the entries of RBA, OSC, ALC etc. categories, wherever made, are subject to production of valid certificates to be issued by the competent authority.


