In pursuance to the provisions of clause (a), (b) sub-section (3) of section (4) of J&K Panchayati Raj Act 1989 amended upto 2016 and clause (a), (b) & (c) of rule (4) of Panchayati Raj Rules 1996 amended upto 2016, Director Rural Development, Jammu has been appointed as prescribed authority for notifying the Sarpanch/Panch Constituencies reserved for SC/ST/Women in the Panchayat Election 2017 of Jammu Division of J&K State.

1. The Panchayat wise population data has been adopted from census 2011, duly authenticated by Block Development Officers and District Panchayat Officers.
2. The Panchayat wise population data of 2011 census has been segregated Ward wise/Panch Constituency wise into SC/ST and others, duly authenticated by Block Development Officers & District Panchayat Officers.
3. The basic data so received has been worked out into %age population of SC/ST and others.
4. The Ward/Panch Constituencies have been proposed for reservation as SC/ST on the basis of population proportion in the concerned Ward/Panch Constituency and similarly, the Sarpanch Constituencies within the Block are also being proposed for reservation for SC/ST on the same pattern as adopted in case of Panch Constituencies.
5. 33% reservation for Women for Panch Constituencies are being adopted on rotational basis as against the 2011 Elections i.e. (2,5,8) and Sarpanch constituencies are being reserved first time in pursuance to the Provisions

Draft proposal for reservation of SC/ST/Women (Panch Constituency) and SC/ST/Women for Sarpanch is prepared for all Blocks of Jammu Division as per Annexure "A" and is uploaded on Official Website of Director Rural Development Jammu (www.drdj.nic.in) for response of general public of the concerned Panchayats/Blocks with the request to go through the draft proposal and objections/suggestions, if any to the draft proposal, should reach to concerned Block Development Officer within 07 days (upto 04-01-2018), after which no objections/suggestions shall be entertained.

Further, objections and suggestions if any, so received in the concerned Block shall be examined by a committee headed by District Panchayat Officer of the concerned district and other members of such committee shall be :-

1. Block Development Officer of the concerned Block.
2. Inspector Panchayat of the concerned Block (Senior most VLW to be nominated by the BDO in case of non availability of Inspector Panchayat).

The committee shall examine the objections/suggestions by 06-01-2018 by all means, and recommend the same to this Directorate for rectification, if any.
