Sub: Final Notice for reservation for SC/ST/Women for Panch Constituencies / Panchayat Halqas of Block Bhalwal, Khour, Mandal Phallian, Marh, Nagrota & Satwari of District Jammu, Block Samba of District Samba & Block Bhagwah of District Doda.

NOTICE

DATED :- 08 - 10 - 2018

Consequent upon issuance of SRO No. 45 of 2012, dated: 30-01-2012 and SRO 268 dated: 11-06-2018 issued by the Housing & Urban Development Department and SROs 383 & 385 dated: 07-09-2018 issued by Administrative Department, certain Panchayats of Rural areas have been de-notified and included in Municipal areas and the same has resulted in creation of new Panchayats and re-determination of Panch Constituencies.

Whereas as per the Sub Section 2 (jj) of Panchayati Raj Act 1989 amended from time to time Chief Electoral Officer, J&K notified the newly created Panchayats vide Notification No:5402/CEO/Pyt/2018/2152-62 dated:24-09-2018.

Whereas in pursuance of Clauses (a), (b) & (c) of sub Rule (1) of Rule 4 of Panchayati Raj Rules 1996 amended up to 2018, Director Rural Development has been appointed as the prescribed authority for notifying the Sarpanch/Panch Constituencies reserved for SC/ST/Women in the Panchayat Elections of 2018 of Jammu Division.

Whereas the Ward/Panch Constituencies are to be reserved for the SC/ST communities on the basis of population and similarly, the Sarpanch Constituencies within the Blocks are to be reserved for the SCs/STs on the formula adopted for Panch Constituencies.

Whereas 33% reservation for women for Panch Constituencies are being adopted on rotational basis with roster 2,5,8,....., i.e. (2,5,8) and Sarpanch constituencies are being reserved for the first time in pursuance of the provisions in clause (a) & (b) of Subsection 3 of Section 4 of Panchayati Raj Act 1989 amended from time to time as per the roaster - 1,4,7,10,13,16,19,22,25,28,31,34,37,40,43.

Whereas, the draft proposal for SC/ST/Women reservation for Panch Constituencies / Panchayat Halqas was put into public domain for inviting objections through notice published on 28.09.2018 in leading English, Hindi & Urdu news papers in respect of Block


