

**Dated: 01.07.2015**

Instructions have time and again been issued to ensure voluntary disclosure of the information in terms of Section 4 (1) (b) of the Jammu & Kashmir Right to Information Act, 2009. However, it has been observed that most of the departments are still deficient with regard to hosting the requisite information on their official websites and, in some cases, the official websites are not being updated on a regular basis. Besides, some departments still have not launched their official websites.

It is, therefore, impressed upon the Administrative Secretaries, Divisional Commissioners, Heads of Departments and Deputy Commissioners to implement the instructions issued vide Circulars No. 07-GAD of 2015, dated 10.02.2015, and 19-GAD of 2015, dated 22.03.2015, in letter and spirit.
