The concerned Block Development Officer shall assign the charge of 2-3 contiguous Panchayat Halqas to aforementioned appointees.

The appointment of above candidates shall be subject to the following terms and conditions:-

- 1. The appointees shall report to concerned Block Development Officer within a period of 21 days from the date of issuance of this order, failing which their appointment shall be deemed to have been cancelled without any notice in terms of circular No. 08-JK (GAD) of 2019 dated: 04-12-2019 issued by the General Administration Department, J&K.
- 2. Their appointment shall be governed by the Government order No. 391-F of 2019 dated 11-07-2019 issued by the Finance Department J&K.
- 3. The salary of the appointees shall be drawn in terms of SRO-202 dated 30-06-2015 read with S.O. 194 dated 17-06-2020 issued by the General Administration Department J&K. During the first period of two years, the appointees shall be entitled to minimum scale of pay applicable to the post.
- 4. The appointees at the time of joining shall produce following testimonials in original to be verified by the concerned DDO from the respective issuing authorities and the salary be released only after receipt of satisfactory verification reports in this regard:
