- 3. The salary of the appointee shall be drawn in terms of SRO-202 dated 30-06-2015 read with S.O. 194 dated 17-06-2020 issued by the General Administration Department J&K. During the first period of two years, the appointees shall be entitled to minimum scale of pay applicable to the post.
