3. The salary of the appointees shall be drawn in terms of SRO-202 dated 30-06-2015 read with S.O. 194 dated 17-06-2020 issued by the General Administration Department J&K. During the first period of two years, the appointees shall be entitled to minimum scale of pay applicable to the post.

- 6. The appointees shall be on probation for a period of two years and completion of probation period shall be subject to successful completion of training modules and qualifying the related examination.
- 7. The cadre /transfer/performance appraisal of the above appointees shall be governed by Government order No. 373-F of 2019 dated 27-06-2019 issued by the Finance Department J&K.

8. The appointment shall be deemed to be cancelled ab-initio if at any stage it emerges that the certificates/testimonials produced by the candidate are fake or forged or otherwise and appropriate legal action will be initiated in such case(s).

- 9. The seniority of the members of cadre shall be regulated under J&K Civil Service (Classification, Control and Appeal) Rules, 1956 and shall be fixed in accordance with the merit obtained by them in Panchayat Accounts Assistants Examination on the date of their passing it.
