- 1. The appointee shall report to concerned Block Development Officer within a period of 21 days from the date of issuance of this order, failing which his appointment shall deemed to have been cancelled without any notice in terms of circular No. 08-JK (GAD) of 2019 dated: 04-12-2019 issued by the General Administration Department, J&K.
- 2. His appointment shall be governed by the Government order No. 391-F of 2019 Dated: 11-07-2019 issued by the Finance Department J&K.
- 3. The salary of the appointee shall be drawn in terms of SRO-202 dated 30-06-2015 read with S.O. 194 dated 17-06-2020 issued by the General Administration Department J&K. The appointee shall be entitled to minimum scale of pay applicable to the post during the first two years,

- 6. The appointee shall be on probation for a period of two years and completion of probation period shall be subject to successful completion of training modules and qualifying the related examination.
- 7. The cadre /transfer/performance appraisal of the above appointees shall be governed by Government order No. 373-F of 2019 dated 27-06-2019 issued by the Finance Department J&K.
- 8. The appointment shall be deemed to be cancelled ab-initio if at any stage it emerges that the certificates/testimonials produced by the candidate are fake or forged or otherwise and appropriate legal action will be initiated in such case(s).
- 9. The seniority of the members of cadre shall be regulated under J&K Civil Service (Classification, Control and Appeal) Rules, 1956 and shall be fixed in accordance with the merit obtained by them in Panchayat Accounts Assistants Examination on the date of their passing it.
- 10. The appointments shall also be subject to the outcome of the writ petitions, if any, pending in any court (s) of law.
