1. They shall report to this Directorate within a period of seven (07) days from the date of issuance of their engagement order and produce following documents in original without which concerned retired Engineer shall not be allowed to join:-
 - a. Date of Birth Certificate.
 - b. Academic/Technical Qualification Certificate.
 - c. Attested copy of Service Book.
 - d. Original Pension Book.

2. The engagees shall submit an affidavit duly attested by First Class Judicial Magistrate to the effect that there is no Departmental Enquiry/RDA/Criminal Proceedings pending against them or contemplated to be initiated against them in the Departments from where they have retired and details submitted while applying for contractual engagement in RDD is true to the best of their knowledge. In case, if anything incriminating is found, they shall be liable for disengagement without any notice. Further, the engagees shall affirm that they have been retired as Assistant Engineer in his parent department and are ready to work in any Block of Jammu Division.
3. The period of contract shall be of one (01) year only which shall be further extendable in cases of satisfactory performance and requirement. Contractual engagements are liable to be terminated by the competent authority without assigning any reason, whatsoever, at any time. The contractual engagement shall not confer any right or claim or to any regularization or continuation of service.
4. The engaged retired (Forty Thousand) Assistant Engineers shall be paid consolidated amount of Rs. 40,000/- (Forty Thousand) per month.
5. They will not be entitled to any kind of regular leave except (Casual Leave) on pro-rata basis.
6. Working days and working hours shall be same as are applicable in case of other serving officers and employees of the Department.
