The concerned Block Development Officer shall assign the charge of 2-3 contiguous Panchayat Halqas to the aforementioned appointee.

The appointment of above candidate shall be subject to the following terms and conditions:

1. The appointee shall report to concerned Block Development Officer within a period of 21 days from the date of issuance of this order, failing which his appointment shall be deemed to have been cancelled without any notice in terms of circular No. 08-JK (GAD) of 2019 dated: 04-12-2019 issued by the General Administration Department, J&K.
2. His appointment shall be governed by the Government order No. 391-F of 2019 dated: 11-07-2019 issued by the Finance Department J&K.
3. The salary of the appointee shall be drawn in terms of SRO-202 dated 30-06-2015 read with S.O.194 dated: 17-06-2020 issued by the General Administration Department J&K. During the first two years period, the appointee shall be entitled to minimum scale of pay applicable to the post.
4. The appointee at the time of joining shall produce following testimonials in original to be verified by the concerned DDO from respective issuing authorities and the salary be released only after receipt of satisfactory verification reports in this regard:-
 - i) Domicile Certificate
 - ii) Date of birth certificate
 - iii) Qualification certificate(s)
 - iv) Category certificate, if any.
 - v) NOC from Employment Department concerned
 - vi) NOC from General Manager DIC concerned
 - vii) Physical Fitness certificate.
5. The appointee shall be imparted training in terms of Schedule-I to Government order No. 3912-F of 2019 dated: 11-07-2019 issued by the Finance Department.
6. The appointee shall be on probation for a period of two years and completion of probation period shall be subject to successful completion of training modules and qualifying the related examination.
7. The cadre /transfer/performance appraisal of the above appointee shall be governed by Government order No. 373-F of 2019 dated: 27-06-2019 issued by the Finance Department J&K.
8. The appointment shall be deemed to be cancelled ab-initio if at any stage it emerges that the certificates/testimonials produced by the candidate are fake or forged or otherwise and appropriate legal action shall be initiated in such case(s).

9. The seniority of the members of cadre shall be regulated under J&K Civil Service (Classification, Control and Appeal) Rules, 1956 and shall be fixed in accordance with the merit obtained by them in Panchayat Accounts Assistants Examination on the date of their passing it.
