The appointment of above candidates shall be subject to the following terms and conditions:

1. The appointees shall report to concerned Block Development Officer within a period of 21 days from the date of issuance of this order, failing which his/her appointment shall be deemed to have been cancelled without any notice in terms of Circular No: 08-JK (GAD) of 2019 Dated: 04-12-2019 issued by the General Administration Department, J&K.
2. Their appointment shall be governed by the Government Order No: 391-F of 2019 Dated: 11-07-2019 issued by the Finance Department J&K.
3. The appointees at the time of joining shall produce following testimonials in original to be verified by the concerned DDO from respective issuing authorities and the salary be released only after receipt of satisfactory verification reports in this regard:
 - i) Domicile Certificate issued by competent authority.
 - ii) Matriculation/Date of birth certificate
 - iii) Academic/Technical Qualification certificate(s)
 - iv) Category certificate, if any.
 - v) Certificate from District Industries Centre(DIC) and District Employment & Counselling Centre to the effect that no loan under any self-employment scheme has been availed by the appointee
 - vi) Physical Fitness certificate

5. The appointee shall be imparted training in terms of Schedule-I to Government Order No: 3912-F of 2019 Dated: 11-07-2019 issued by the Finance Department.
6. The appointee shall be on probation for a period of two years and completion of probation period shall be subject to successful completion of training modules and qualifying the related examination.
7. The cadre /transfer/performance appraisal of the above appointee shall be governed by Government Order No: 373-F of 2019 Dated: 27-06-2019 issued by the Finance Department J&K.
8. The appointee shall give an undertaking in the shape of an affidavit to the effect that if on verification, his qualification/date of Birth/Reserved Category Certificate from the concerned issuing authorities are found fake/forged his appointment shall be deemed to be cancelled ab-initio. Further, if at any stage it emerges that the certificates/testimonials produced by the candidate are fake or forged or otherwise and appropriate legal action shall be initiated in such case(s).
9. The salary of the appointee shall not be drawn and disbursed to him unless the satisfactory reports in respect of genuineness of qualification/DoB and reserved category certificate, if any, are received from concerned authorities/agency.
10. The seniority of the members of cadre shall be regulated under J&K Civil Service (Classification, Control and Appeal) Rules, 1956 and shall be fixed in accordance with the merit obtained by them in Panchayat Accounts Assistants Examination on the date of their passing it.
11. The appointment of the candidate shall be governed by the "New Pension Scheme" in terms of SRO-400 of 2019 Dated 24-12-2019.
12. The appointment shall also be subject to the outcome of the writ petition, (if any) are pending in any court (s) of law.
