In terms of SRO-43 of 1994 dated: 22-02-1994 as amended from time to time read with Proviso to Rule 18 of S.O: 429 of 2022 Dated: 06.09.2022, Sanction is hereby accorded to the temporary appointment of Sh. Sajjad Ahmed S/o Late Sh. Mohd Khalil Bali (Ex-VLW) R/o Mundkhal Pogal Tehsil Pogal Paristan (Ukhral) District Ramban as Orderly (re-designated as "Multitasking Staff" (MTS) in the pay level SL1 (14800-47100) against an available vacancy in District Cadre Ramban on compassionate grounds.

The appointee shall report to Assistant Commissioner Development, Ramban within a period of 21 days from the date of issuance of this order, failing which his appointment shall be deemed to have been cancelled without any further notice after the expiry of the stipulated period.

The appointee shall be allowed to join only on the production of the following documents/certificates (in original) to be verified subsequently:

1. Qualification Certificate.
2. Date of Birth Certificate.
3. Domicile Certificate.
4. Medical Fitness/Health Certificate from concerned CMO of District.
5. Death Certificate of Late Sh. Mohd Khalil Bali (Ex-VLW).
6. Dependent Certificate issued by competent authority.
7. Legal Heir Certificate.
8. Certificate from DIC and District Employment & counselling Department to the effect that No Loan under self-employment scheme availed/received.
9. All other documents as are required under SRO-43 of 1994.

The appointment of the appointee shall further be subject to the following conditions:

- 1) That appointee shall give an undertaking in the shape of an affidavit to the effect that if, on verification, genuineness of the qualification certificates from the concerned issuing authority is found fake/forged, the claim of the appointee for appointment as Orderly (re-designated as "Multitasking Staff" (MTS) shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against him.

- II) The salary of the appointee shall not be drawn and disbursed to him unless a satisfactory report in respect of (I) above is received in his favour.
 - III) The appointee shall be initially on probation for a period of two years.
 - IV) The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated: 24-12-2009.
 - V) The appointment of the candidate shall be governed in terms of S.O 425 of 2022 Dated: 06-09-2022.
 - VI) If the appointee fails to join within a period of 21 (twenty one) days from the date of issuance of this order he shall forego his right to appointment which shall be deemed to have been cancelled ab-initio without any further notice.
