Officer concerned @ Rs 40.00 lac per unit in summer zone and Rs 42.00 lac per unit in winter zone for office accommodation and Rs 32.50 lac per unit for summer

zone and Rs 34.50 lac in winter zone for residential accommodation

(D) Designation of Assistant Commissioner's Development as Nodal Officer's for the respective District's to identify suitable premises preferably Panchayat Ghars or rented accommodation where Panchayat Ghars are not available, for making the new units functional. The identification shall be completed within 15 days from the date of issue of this order.

(E) Purchase of the office automation equipment / furniture for being provided to the new CD Blocks at an average scale of Rs 3.00 lacs/ CD Block for which funds are being released by Planning & Development Department shortly through Director Rural Development Jammu / Kashmir.




