Sub: -Reservation of Block Development Council Constituencies for SCs, STs & Women in respect of Jammu Division.

Whereas, in pursuance of the provisions of Section 27(3) of the J&K Panchayati Raj Act, 1989 and Rule 2(1) (i) of the J&K Panchayati Raj Rules 1996 amended upto Oct.2018, the Director, Rural Development, Jammu is the prescribed authority to reserve the Block Development Council constituencies for Scheduled Castes, Scheduled Tribes and Women in every District of Jammu Division.

Whereas, as per the section 27 (3) proviso of the J&K Panchayati Raj Act 1989 amended upto October 2018, the offices of the Chairpersons of Block Development Councils in the District are to be reserved for SCs & STs in the same proportion as the population of SCs and STs in that District; and 33% of the constituencies are to be reserved for women.

Whereas, a draft proposal was issued vide this office Notices No.02 to 04 of 2019 dated 31-07-2019, 10-08-2019 & 27-08-2019 respectively for the reservation of BDC constituencies for SCs, STs and Women was put into the public domain for inviting objections in leading English/ Hindi/ Urdu local dailies and the official website of this office (www.drdj.nic.in.)

Whereas, some objections/ representations were received by the District Panchayat Officers of the respective Districts and the same were furnished to this office alongwith their specific comments/recommendations for taking final decision.

Whereas, the objections / recommendations furnished by the District Panchayat Officers were examined and disposed off in light of the provisions of Section 27 of the J&K Panchayati Raj Act, 1989 amended upto October 2019.

Now, therefore, in exercise of the powers conferred under Section 27 (3) of the J&K Panchayati Raj Act, 1989 and Rule 2(1) (i) of the J&K Panchayati Raj Rules 1996, amended upto October 2018, the final reservation for Block Development Council Constituencies for SCs, STs and Women in every District of Jammu Division is notified as Annexure-A and uploaded on official website of this Directorate (www.drdj.nic.in).
