- 4. Certificate from Deputy Director, Employment and General Manager, DIC concerned relating to the non-receipt of any loan by the candidate under Self Employment Scheme and Prime Minister Rozgar Yojana.
- 5. Category certificate if any required.

- b) Verification of the qualification certificate from the concerned issuing authorities.
- c) Salary of the appointee shall not be drawn and disbursed to him/her unless satisfactory report is received.

d) The appointee shall be on probation for a period of two years.

e) Subject to the outcome of writ petition, if any, pending report the competent Court of law.

The inter-se-seniority of the Village Level Workers will be prepared by the Assistant Commissioner Development Reasi reckoning the merit of each candidate as envisaged in the select list received from the Service Selection Board J&K vide their letter referred to above.
