The appointee shall report to the Assistant Commissioner Development, Ramban within a period of 15 (Fifteen) days failing which his/her appointment shall be deemed to have been cancelled without any further notice after the expiry of the stipulated period.

The appointee shall be allowed to join only on the production of the following certificates in original:-


1. Permanent Resident Certificate issued by the competent authority.
2. Academic qualification certificate
3. Matriculation/Date of Birth Certificate
4. Health Certificate issued by the Chief Medical Officer.

5. Certificates from Deputy Director, Employment and General Manager, DIC concerned relating to the non-receipt of any loan by the candidate under Self Employment scheme and Prime Minister Rozgar Yojana.
6. Relevant Category certificate (in case of candidates belonging to reserved categories).

The appointment of the above candidates as Class-IV (Orderlies) shall further be subject to the following conditions:-

- a). Each appointee shall give an undertaking in the shape of an affidavit to the effect that in case adverse report about his/her character and antecedents is received from the Inspector General of Police, CID, J & K, to whom a reference shall be made by the Assistant Commissioner Development, Ramban, the candidate shall have no right to claim his/her appointment as Class-IV (Orderly) and his/her appointment as such shall be deemed to have cancelled *ab-initio*.
- b). Verification/genuineness of the qualification certificates, reserved category certificates (wherever applicable) from the concerned issuing authorities.
- c). Salary of the appointee shall not be drawn and disbursed to them unless satisfactory report in respect of (a) & (b) above are received in their favour.
- d). The appointees shall be on probation for a period of two years.

The inter-se-seniority of the above appointees shall be in order in which their names appear in this Order which is in accordance with the merit secured by these appointees as per the select list furnished by the Chairman Distt. Level Recruitment Committee (ACD) Ramban.
