 - a) The appointee shall give an undertaking in the shape of an affidavit to the effect that in case any adverse report about his Character and antecedents is received from the Addl. Director General of Police, CID, J&K to whom a reference shall be made by the Assistant Commissioner Development Kishtwar the candidate shall have no right to claim his appointment as Village Level Worker and as such shall be deemed to have been cancelled ab-initio.
 - b) Verification of the qualification certificate from the concerned issuing authorities.
 - c) Salary of the appointee shall not be drawn and disbursed to him/her unless satisfactory report is received.

d) The appointee shall be on probation for a period of two years.

The inter-se-seniority of the Village Level Worker will be prepared by the Assistant Commissioner Development Kishtwar reckoning the merit of each candidate as envisaged in the select list received from the Service Selection Board J&K vide their letter referred to above.
