Two Crore Twenty Seven Lakh Eighty Seven Thousand Seven Hundred Only)** and placement thereof at the disposal of **Controlling Officers** of Rural Development Department of Jammu Division for its further placement at the disposal of subordinate offices as per annexure -A for the Financial Year 2017-18.

The allotment so made is subject to the following conditions:-

1. The DDOs are required to ensure strict implementation of the Government Orders/Circular Instructions, issued from time to time, before utilizing the aforementioned allocations.
2. The expenditure should be incurred uniformly to avoid rush of expenditure.
3. The DDOs will ensure that the expenditure under various object heads is contained within the budget allocation.
4. The DDOs will ensure that the funds so released shall be utilized for the specific purpose without making any diversion.
5. The drawal/expenditure statement & revenue receipts under tax revenue and non-tax revenue should also reach this Directorate on monthly basis invariably by 5th of succeeding month.
6. The Drawing and Disbursing Officer shall book the expenditure to the extent of allotment thus made after observing all the codal formalities.
