Consequent upon issuance of SRO No. 45 of 2012, dated: 30-01-2012 and SRO 268 dated: 11-06-2018 issued by Housing & Urban Development Department and SRO 383, 385 dated: 07-09-2018 issued by Administrative Department, certain Panchayats of Rural areas have been de-notified and included in Municipal areas and it results in creation of new Panchayats and re-determination of Panch Constituencies.

Whereas as per the Sub Section 2 (jj) of Panchayati Raj Act 1989 amended from time to time Chief Electoral Officer, J&K notified the newly created Panchayats vide Notification No:5402/CEO/Pyt/2018/2152-62 dated:24-09-2018.

Whereas in pursuance to clause (a),(b) & (c) of Panchayati Raj Rules 1996 upto 2018, Director Rural Development has been appointed as the prescribed authority for notifying the Sarpanch/Panch Constituencies reserved for SC/ST/Women in the Panchayat Elections of 2018 of Jammu Division.

Whereas the Ward/Panch Constituencies has been proposed for reservation as SC/ST on the basis of population and similarly, the Sarpanch Constituencies within the Block are being proposed for reservation for SC/ST on the formula being adopted for Panch Constituencies.

Whereas 33% reservation for women for Panch Constituencies are being adopted on rotational basis as against the 2011 i.e. (2,5,8) and Sarpanch constituencies are being reserved first time in pursuance to the provisions of Panchayati Raj Act 1989 amended time to time as per the roaster 1,4,7,10,13,16,1,22,25,28,31,34,37,40,43.
